

Detailed Procedures of 24 + months Jr. Doctor's Post Graduate Training and Polish Medical License Program



The 24 + months training programs are offered in partnership with Polish teaching & non-teaching hospitals, and Polish Medical Universities



License to Practice in Poland and in EU

The graduate acquires the right to practice as a physician in Poland after completing a 13-month postgraduate internship and submitting, with a positive result, the State Medical Final Examination (LEK). The rules for exercising the medical profession are regulated by the Act of 5 December 1996 on the professions of a physician and a dentist (consolidated text: Journal of Laws of 2021, it. 790, as amended).

The graduate (the Polish medical licensed candidates) also acquires the right to practice as a physician in **other European Union countries** according to the principles set out in Directive 2005/36/WE of the European Parliament and of the Council of 7th September 2005 on the recognition of professional qualifications (EU Journal of Laws L 255 of 30th September 2005, p.22, as amended). The right to practice in other EU countries is also determined by the legal regulations of those individual (EU) states.




There are 3 types of LICENSES in Poland for Jr. Doctors

- 1. Ograniczona PWZ limited license to practice
- 2. PWZ license to practice without specialization
- 3. PWZ ze Specjalizacją license to practice with specialization

AMA 24-month comprehensive training program prepares the candidate to pass two exams and also prepares qualified candidates to secure PWZ limited License to practice: After NIL and Nostrification exams, candidates would receive a limited license to practice and can start a 13-month clinical training. (Further, after / during, or even before completing the 13-month training, a candidate must take a final exam LEK to get a PWZ – license to practice without specialization).

Medical Specialization in Poland: After that, a candidate can take a 4-6 years residency and exam PES to receive a **license with specialization**.



Possible Compensation during the Polish Licensing Period

During the **13 months of the clinical training period**, candidates would **receive 5,000 Zloty (about US\$1,250 +)** per month stipend (candidate can earn US\$1,500 + some part-time employment opportunity, during the 13 months of clinical training period). As licensed Jr. Doctors, candidates can earn between US\$4,000 to US\$6,000 per month.

Specialization in Poland: Qualified candidates can do the medical specialization free of charge in Poland (after getting the Jr.doctor Polish License).

During the specialization Period, candidate can receive 3,000-5,000 USD per month during 4-6 years .

PROCEDURE for the international Jr. Doctor candidates with experience and specialization background in EU and/or elsewhere

First securing the limited license to work without the Polish Medical license:

- learning the Polish language;
- giving documents to the Polish ministry to receive a Limited license to work as a doctor;
- preparing for the interview;
- in about two to three months after sending the documents we can expect an interview in the Polish language with the Ministry;
- receiving a Limited license to work in Poland;
- preparing CV and sending it to different Polish "potential" employers (we began the unofficial communication and candidates' before receiving the limited Polish license to work);
- start working as a doctor's assistant in a Polish hospital/clinic.

Second Step: While working as a doctor's assistant, prepare to take the Polish Medical license:

- learning Polish at work and with the teacher + preparing to pass (NIL and Nostrification);
- Passing NIL and Nostrification exams;
- starting 13 months program.

Salary: Candidates can get a salary between US\$2,500 to US\$5,000 per month, depending upon the candidate's professional qualifications, and the Polish employer.

- Making copies and photos;
- Requesting needed documents from the origin government within 3 months of its issuance .


