Admission qualification:

- **Bachelor's degree in Nursing** (3 years and four years candidates can join)
- **Nursing License** in a home country
- the academic program is offered in English, so basic English level is a requirement

RN-NCLEX (USA Nursing License)



Nurse candidates come to our campus in Poland for two years of Master's program In Nursing in English (4 semesters). While doing the Master's degree, we will also prepare the candidates for the **RN-NCLEX** (USA Nursing License; a special training fee is applicable). The **RN-NCLEX** training can be completed and can pass the USA licensing exam during the 1st year of your Master's studies. The Master's Nursing degree curriculum is the USA Integrated curriculum.

Upon securing the RN-NCLEX license, candidates can apply for **USA Jobs** and have the opportunity to work in the USA by the time candidates complete the Master's nursing program/studies.

Having a Master's Degree in Nursing & with the RN-NCLEX license, candidates can join the Nurse Practitioner licensing program in the USA, while working. *[Nurse Practitioners, see patients in the USA, just like medical doctors, and enjoy higher income and unique professional opportunities.]*

One-month study tour to the USA

AMA is also offering a one-month optional **study tour program in the USA** for our Master`s students in Poland. After candidates pass the US nursing license and after the 1st year of studies, qualified candidates can also apply for jobs in the USA.

Nurses in the USA play a vital role in the healthcare system, providing patient care, administering medications, educating patients and families, and collaborating with other healthcare professionals. They work in a variety of settings, including hospitals, clinics, nursing homes, schools, and community health centers.



Alternative Professional Options in Europe

The other best options include the possibility for our master's students to work in Poland (they can earn up to US\$2,500 monthly salary in Poland) OR candidates can work in other EU countries including Italy, France, Germany, Switzerland, the UK, Ireland, and Scandinavian countries, etc. or any part of the world.

AMA-AP Campus Masters nursing students have the opportunity to get paid summer training, during the summer study break period

ERASMUS +

candidates would be able to live and study at one of the other EU member states (AP-approved university/faculty of nursing) with NO additional fee, this includes the accommodation, living expenses, local transportation, etc., under the Erasmus program

Such cross-country EU training would be an exceptional value AMA-AP nursing students can have and it will help our nursing program graduates secure employment and paid training opportunities after studies in the EU countries and or internationally



Free Language Classes

Starting from the 1st semester of studies, candidates can join AMA's optional **German, French, and Italian language classes** (candidates can choose up to two language classes), free of charge. Such EU language training can prepare the candidate to be "more" qualified to take the paid practical summer training outside of Poland. Further, it will also help the candidate to secure employment offers or paid apprenticeships in other EU countries, after securing the Nursing degree from AP.

Compensation for the Initial Employment. AMA-AP nursing program qualified graduates could receive between **Euro 2,000 and Euro 3,000 per month salary**, by taking an employment contract with AMA partner healthcare facilities in the EU countries; the initial monthly salary range depends upon the actual employment facilities and candidates' communications skills/level in the local language.



Tuition Fee for Master`s Program per Year

5,500 EUR

Two year program with 120 ECTS Credits and candidates complete it with four semesters of study

NCLEX

3,500 – 5,500 EUR

The duration of the program is from 3 to 6 months. It is possible to move out from Poland after passing the 1st year of Master`s studies and passing the NCLEX exams
